A note about the tax deductibility of the ticket cost. Many have asked about this and we have received guidance on this from knowledgeable experts at AAUW National. In their words: "The cost of the ticket should not be considered tax deductible as goods or services was rendered for that ticket's cost. The IRS mandates that no goods or services can be received for a donation to be considered tax-deductible. Anything paid above the cost of the ticket, however, could be considered a tax deductible donation."

#### MEMBER SPOTLIGHT

#### MEET BEA HOLT



This former insurance executive has made her mark on the Venice branch of AAUW and a number of other organizations she has joined since retiring in 2010.

A graduate of St. Joseph's University in Philadelphia, Bea earned a degree in health care administration there.

Connecticut was home. It is where she grew up and lived for many years, eventually becoming vice president of a medical malpractice insurance

company based in Glastonbury, near Hartford. In 1995, she married Richard Mullin, a steel company executive and was widowed in 2005.

Venice became a destination when her sister, Carol Sbabo and husband bought a home here back in the '90s. She followed suit in 2004, purchasing a condominium on the Island. She likes Venice because it is "a smaller town near the water and an easy place to walk around. Venice has great resources for the arts as well."

Retirement for her meant time to pursue her wide-ranging interests. With AAUW, she jumped in as co-chair of the Home Tour in 2011 with Shirley Reid. She continued in that role with Kathy Black from 2012 to 2015.

She sees our branch as evolving, "from a women's group to a true member of the non-profit community, worthy of receiving grants." To that end, she initiated and maintains a Giving Partner Profile for the branch, which is an on-line repository of data that qualifies a non-profit as eligible to receive grants. That information is available at the Community Foundation of Sarasota County and the Gulf Coast Community Foundation where it can be viewed by potential donors. She says, "Our profiles with these organizations are kind of like Good Housekeeping seals of approval for our branch."

Two years ago, she took on a role as development chair for Venice branch, recognizing "how difficult it was becoming to manage the scholarship funds we were raising." She worked directly with the branch scholarship committee. The endowment of a Venice AAUW Scholarship Fund with Gulf Coast as a partner is the outcome of her efforts. The additional funds raised by our Home Tour will be supervised by branch members and also flow through the Foundation. "This maximizes our ability to attract recipients and offers a complete service to deserving women."

Her ongoing AAUW involvement includes Outdoor Adventures, a special interest group (SIG) she chairs which has sponsored "everything from zip-lining, horseback riding and kayaking" to expeditions to museums and other less physically challenging activities.

She is also a board member for two other organizations, the Venice Area Historical Society (VAHS) and the Venice Board of Performing Arts, which manages the Venice Performing Arts Center (VPAC).

Travel is another facet of her busy life. In addition to far-flung exotic destinations where she has already been — including Uzbekistan, Tibet, India and Nepal — she has an upcoming trip to Dubai. Closer to her home base, she explains she has six stepchildren who live in six different states and a brother in New Orleans. You never quite know where she'll turn up next!



### SCHOLARSHIP ENDOWMENT FUND LAUNCHED BY AAUW VENICE

An endowment fund of \$25,000 to provide scholarships for Sarasota County area women has been established with the Gulf Coast Community Foundation by our Venice branch.

This money was raised through recent Home Tours which the chapter holds annually on the second Friday in February. "In the past, we have searched for and screened applicants with our own scholarship committee," according to chapter president Kathleen Pickering. "The broad-based resources of the Gulf Coast Community Foundation will enable us to reach a larger number of women needing educational support. We are also hopeful that the investing expertise of the Foundation will grow this fund and enable us to assist even more women." In addition to the endowment, AAUW Venice will channel additional funds from the 2018 Home

Tour, scheduled for February 9, for immediate distribution as scholarships. In 2017, 10 scholarships of \$2,000 each were awarded from Home Tour receipts.
